**RE: ROCK, SAND & GRAVEL AGREEMENT/2018-2023**

Dear Mr. Velasquez:

The negotiated increase due October 1, 2020, in the amount of One Dollar and eighty-five cents (\$1.85) will be distributed as follows.

*Effective October 1, 2020*, the Hourly Wage Rates will be increased a total of sixty cents (60¢), as noted below.

The Defined Contribution Plan (Annuity) will be increased One Dollar (\$1.00) to Two Dollars and fifty cents (\$2.50) for all hours worked or paid.

The monthly flat rate contribution for Health and Welfare will be increased Thirty Dollars (\$30.00) to One Thousand Four Hundred Thirty-Seven Dollars (\$1,437.00) per month, per employee. Based on the average hours reported to the Trust Fund Office, the hourly rate to compute this Thirty Dollars (\$30.00), is twenty-five cents (25¢) per hour.

Therefore, the hourly Health and Welfare rate will be increased twenty-five cents (25¢), to Eleven Dollars and ninety-five cents (\$11.95) for all hours worked or paid.

*Effective October 1, 2018, it was agreed in negotiations that all Heavy Duty Repairmen or Heavy Duty Repairmen Combinations shall receive a fifty cent (50¢) per hour tool allowance. This tool allowance shall be added to his classification and shall become his base rate of pay.*

\*The Union may elect as its option, upon at least sixty (60) days' written notice to allocate the increase indicated to: (1) Hourly Wage Rates, (2) Health and Welfare, (3) Pension, (4) Vacation-Holiday and/or Supplemental Dues (5) Joint Apprenticeship/Journeyman Retraining and (6) Defined Contribution Plan (Annuity).



**Work Coverage:** It is agreed that the Helper Classification will be allowed to use the backhoe for trash cleanup purposes only. It is also agreed the Helper Classification can utilize the forklift to off load delivery trucks. The Helpers will also run the clarifier and belt press. All repairs/welding to be done by Local No. 12 Operating Engineers.
